Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PNPA now invites bid for *the procurement of the above-captioned package. Completion of works would be 65 days after the issuance of the Notice to Proceed.* Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. *Instructions to Bidders.*

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the ***BAC Secretariat, LIS Office, 1st Floor, Admin Building, Camp Gen. Mariano N. Castañeda, Brgy. Tartaria, Silang, Cavite*** and inspect the Bidding Documents at the address given above from ***9:00am – 4:00pm Monday – Friday***.
5. A complete set of Bidding Documents may be purchased by interested Bidders on ***November 16, 2017***, from the address above upon payment of non-refundable fees for the Bidding Documents in the amount of the following:

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders who are interested to participate shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The PNPA will hold a Pre-Bid Conference on ***November 27, 2017, 10AM at the PNPA Conference Room at Camp Gen. Mariano N. Castañeda, Brgy. Tartaria, Silang, Cavite*** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before ***9AM, December 11, 2017, PNPA Conference Room at Camp Gen. Mariano N. Castañeda, Brgy. Tartaria, Silang, Cavite***. All Bids must be accompanied by a bid security, preferably Manager’s Check, in the amount stated in ITB Clause 18.

Bid opening shall be on ***10AM, December 11, 2017, PNPA Conference Room at Camp Gen. Mariano N. Castañeda, Brgy. Tartaria, Silang, Cavite***. Bids will be opened in the

presence of the Bidders' representatives who chose to attend at the address below. Late bids shall not be accepted.

8. **The PNPA reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.**
